Supervisor Election & Absentee Ballots




In accordance with Ch. 940 of the Ohio Revised Code, the Ohio Soil & Water Conservation Commission will cause an election to be held electing two (2) supervisors to fill the expiring terms of Parry Cochran and Scott Stoller. The supervisors will be elected for a three (3) year term, beginning January 1, 2017. The candidates running for Wayne SWCD Board of Supervisors to be elected at the Annual Meeting on Nov. 17th are Parry Cochran, Scott Stoller and Dustin Ramsier. Please see page 2 for a brief bio of the candidates. Eligible voters and candidates shall be 18 years of age by day of election and shall reside within or own land within Wayne County. If you are unable to attend the meeting and would like to vote, please cast your absentee ballot at the Wayne SWCD from 8 am to 4:30 pm weekdays, prior to the day of election, and from 8 am to noon on election day. Absentee ballots submitted via mail must arrive at the Wayne SWCD office before November 17th.

We are Collecting Milkweed Pods now till the end of October!



Wayne SWCD is pleased to partner with OPHI & a statewide program to help collect common or swamp milkweed seed pods. Collect the pods when they are dry and gray or brown in color and put them in a paper sack and bring them into our office by the end of October! MEET THE CANDIDATES:



PARRY COCHRAN

Parry lives in Plain Township and farms 600 acres of corn, soybeans, wheat and hay. He raises custom dairy replacement heifers. Conservation practices installed on his farm are waterways, cover crops, feedlot runoff diversion system, forestry stewardship plan, improve woodlot,

fertilizer containment building, silage storage area and 95% no-till cropping.

Parry is a member of Grace Church, and is actively involved with his children's activities.

Parry and his wife Susie have three children Aaron, Andrew and Audrey.



DUSTIN RAMSIER

Dustin lives in Milton Township. He farms 110 acres of corn and soybeans. Conservation practices used on the farm are continuous no-till, cover crops, grassed waterways, and a retired pen pack facility with CNMP. He is a Certified Crop

Advisor and is currently a fulltime sales agronomist at Tyler's Grain & Fertilizer Company. Dustin recently earned the "4R Nutrient Management Specialist Certification" under the CCA program.

Dustin is a member of the Rittman Grace Brethren Church and the American Society of Agronomists.

Dustin is married to Rachael and they have three children, Brianna, Dillon and Benjamin.



SCOTT STOLLER

Scott lives in Milton Township. Between owning and renting, Scott and his family operate a 750 acre certified organic dairy farm growing corn, soybeans, wheat, rye, and alfalfa/grass pastures. They milk 160 Holsteins and market all of their milk

through Organic Valley. Scott has installed several conservation practices: waterways, spring developments, 1400 ft. heavy use cattle access lane, developed a Comprehensive Nutrient Management Plan, 250,000 gallon manure storage structure, livestock stream exclusion, woodland management, riparian buffers, and cover crops on all acres.

Scott is a member of the Apostolic Christian Church and the Wayne County Farm Bureau. Scott is married to Charlene and they have eight children and 5 grandchildren.

Leave the Leaves



Take a brake from the rake this fall! Did you know leaves increase fertility of your soil? As they decompose, the nutrients seep into your soil & the cover allows for greater water retention. Leaves provide cover for wildlife like frogs & salamanders. They rely on the fallen leaves for cover and nest material, and finally, leaves provide food with insects for birds and toads. So please leave some leaves!



EQIP Sign Up

EQIP has been one of the best programs to assist local producers with installing conservation practices on their land. The program was established to address resource concerns on cropland, pasture, forest, and headquarter areas. EQIP provides financial assistance for a variety of practices including nutrient management, cover crops, grassed waterways, no-till, livestock waste storage facilities, prescribed grazing systems, woodland invasive species control, seasonal high tunnels, and more.

Applications for the program are accepted on a continuous basis with the deadline for the next signup period **ending October 28th**. Approvals have become more difficult the past couple of years since we are competing statewide with many funds going to distressed watersheds. Potential applicants should work with the SWCD/NRCS staff this fall to develop conservation plans for the practices they want to install next year. New Drop off site in Canton Opens

The City of Canton Recycle Center (located at 742 Schroyer Ave SW) is now a Household Hazardous Waste collection site for all District residents, including residents of Wayne County. Residents simply need to call **330-430-7869** to schedule an appointment to drop off their hazardous waste. Only residents can utilize the no cost HHW collection—no waste from businesses will be accepted.



Acceptable wastes include Flammable Liquids (gasoline, kerosene, mineral spirits, acetone, xylene, lighter fluid, oil-based paint, stain, Thomas Water Seal, varnishes, etc), Aerosols, Pesticides, Insecticides, Herbicides, Fungicides, Corrosive Liquids (naval jelly, muriatic acid, hydrochloric acid, sulfuric acid, toilet cleaners, sodium hydroxide, ammonia, Drano, caustic soda, 409 cleaner), Automotive Fluids (motor oil, antifreeze, hydraulic fluid, gear oil, fryer oil, etc), items that contain Mercury (thermometers, thermostats, switches, etc), Batteries (Nickel Cadmium, Lithium or Lithium-ion, Alkaline, Sealed Lead Acid (gel cells), Lead Acid, etc), Propane Tanks, and Fluorescent Bulbs (tubes, compact, U-tubes, circular).

Protecting our Waterways from Pipeline Work

In September, our office attended the Water Quality Certification public comment meeting held by the Ohio EPA for the proposed ET Rover natural gas pipeline. The Ohio EPA is required to solicit for public comment, in addition to reviewing Rover's application for constructing the pipelines through waterways and wetland, before issuing a 401 water quality permit to allow this work to occur. The EPA indicated at the meeting that if they issue a permit, they do not have the personnel to do much, if any, inspection of the construction work.

Furthermore, the pipeline work planned by all three companies installing pipelines through Wayne County are exempt from the Ohio EPA Storm Water Construction Permit and the Wayne County Storm Water Management Regulations – the rules that outline practices that keep sediment in storm water runoff out of waterways (i.e. silt fence, sediment traps, etc.). Therefore, you will be the first line of defense in protecting the waterways and wetlands on your property during the pipeline construction. Excessive sediment can blind off habitat from fish and macroinvertebrates for many years following its discharge into the waterway.

If you observe sediment entering a waterway or wetland during construction feel free to contact our office and we in turn can relay this information onto the Ohio EPA. Other than the Environmental Inspectors hired by the pipeline companies, you will be the only person looking out for these environmentally sensitive areas not visible from the road.
